APPROVAL OF MAP 19280 FOR WATER APPROPRIATION A-19349

BACKGROUND

1. On April 10, 2015, Jamie Schnakenberg, on behalf of K Four J Farms, LLC, filed in the Department of Natural Resources (Department) application A-19349 for a Permit to Appropriate Water.
2. On July 27, 2015, Jamie Schnakenberg, on behalf of K Four J Farms, LLC, filed in the Department map number 19280 showing land proposed to be irrigated under application A-19349.

ORDER

IT IS HEREBY ORDERED:

1. Map number 19280 is APPROVED.
2. The following is a description of all the land which is authorized to be irrigated (appurtenant land) under surface water appropriation A-19349 as depicted on map number 19280:

Township 15 North, Range 7 East of the 6 <sup>th</sup> P.M. in Saunders County	Acres
Section 32: NW <sup>1</sup> / <sub>4</sub> SW <sup>1</sup> / <sub>4</sub>	37.6

3. Appropriation A-19349 authorizes the appropriator the use of 15.9 acre-feet annually from Roberts Reservoir 254 (storage appropriation A-19348) from a pump site located in the SW<sup>1</sup>/<sub>4</sub>SW<sup>1</sup>/<sub>4</sub> of Section 32, Township 15 North, Range 7 East of the 6<sup>th</sup> P.M. in Saunders, County as depicted on map number 19280.
4. The appropriator is bound by all terms and conditions of the approval of application A-19349.
