APPROVAL OF MAP 19223 FOR WATER APPROPRIATION A-19341

WATER DIVISION 2-F

BACKGROUND

1. On March 23, 2015, Stanley and CherylN Sudbeck filed in the Department of Natural Resources (Department) application A-19341 for a Permit to Appropriate Water.
2. On April 27, 2015, Stanley and CherylN Sudbeck filed in the Department map number 19223 showing land proposed to be irrigated under application A-19341.

ORDER

IT IS HEREBY ORDERED:

1. Map number 19223 is APPROVED.
2. The following land is authorized to be irrigated (appurtenant land) under surface water appropriation A-19341 as depicted on map number 19223 which is made a part of this Order.

Township 30 North, Range 3 East of the
6th P.M. in Cedar County Acres

Section 7: NW¹/₄NW¹/₄ 33.2

3. Appropriation A-19341 has a priority date of March 23, 2015, and authorizes the appropriator the use of water for irrigation of the 33.2 acres of land described above. The water may be diverted from a tributary to East Bow Creek at a point of diversion in the NW¹/₄NW¹/₄ of Section 7, Township 30 North, Range 3 East of the 6th P.M. in Cedar County, as depicted on map number 19223. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum rate of 0.47 cfs (211 gallons per minute).
4. Water diverted shall not exceed the ratio of one cfs for every 70 acres irrigated nor the least amount of water necessary for the production of crops in the exercise of good husbandry. Therefore, in any year when less than the maximum permitted acres are being irrigated, the quantity of water diverted at any time may be restricted to 1/70 cfs for each permitted acre being irrigated that year. This appropriation of water under any circumstance shall be limited annually to 3 acre-feet per acre of land on which water is actually and beneficially applied; not to exceed the least amount of water necessary for the production of crops in the exercise of good husbandry.

5. The appropriator is bound by all terms and conditions of the approval of application A-19341.
