ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-15748

WATER DIVISION 1-A

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that the land appurtenant to surface water appropriation A-15748 is divided into two distinct parcels with multiple owners. A portion of the land appurtenant to A-15748 is held by an unnamed Trust, Ruth Ellen King, Trustee; the remainder is held by Colleen Combs, Karen Schachterle, Dean King and Keith King as tenants in common.
2. Appropriation A-15748 has a priority date of January 15, 1981, and authorizes the use of water for irrigation of the 118.24 acres of land described below. The water may be diverted from Buffalo Creek at a point of diversion located in the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 36, Township 9 North, Range 19 West of the 6th P.M. in Dawson County. The rate that water may be diverted shall not exceed one cubic foot per second (cfs) for every 70 acres irrigated at a maximum rate of 1.68 cfs.
