ORDER OF PARTIAL CANCELLATION OF WATER APPROPRIATION A-1625

WATER DIVISION 2-D

Background

1. Surface water appropriation A-1625 is held by the Whitney Irrigation District (District).
2. Appropriation A-1625, with a priority date of November 7, 1921, authorizes the use of water for irrigation of 7,139.5 acres of land. The water may be diverted from the White River at a point of diversion located in Section 26, Township 32 North, Range 52 West of the 6th P.M. in Dawes County.
3. On October 17, 2008, Relinquishments of Water Appropriation In Part REL-1539, REL-1544 and REL-1549 were filed in the Department by the District and individual landowners relinquishing the right to divert water under appropriation A-1625 to irrigate the 88.6 acres of land described below.

4. All terms and conditions of appropriation A-1625 remain in effect unless specifically changed by this Order.
5. The appropriator must comply with all relevant statutes. This includes, but is not limited to, the following:
 - a. Receiving approval prior to taking any action that changes the location of the point of diversion, a transfer of the location of the place of use, a relinquishment of a portion of the appropriation, the type of use, or the type of appropriation.
 - b. Notify the Department of Natural Resources of any reassignment of relinquished portions of an appropriation.
 - c. Comply with all relevant notices and orders of the Department.

Additional Information

Failure to comply with all laws and regulations pertaining to surface water appropriations and any orders issued by the Director of the Department of Natural Resources may result in the cancellation of the appropriation, temporary closing of the appropriation, administrative penalty, criminal prosecution, or any combination thereof.
