ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-17101

WATER DIVISION 1-B

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-17101 is held by Benkelman Country Club, on behalf of Benkelman Golf Club, Inc.
2. Appropriation A-17101 has a priority date of August 7, 1991, and authorizes the use of water for irrigation of the 58.0 acres of land described below. The water may be diverted from a tributary to the Republican River at points of diversion located on the north and west banks in the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 3 and the NE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 10, both in Township 1 North, Range 37 West of the 6th P.M. in Dundy County. The rate that water may be diverted shall not exceed one cubic foot per second (cfs) for every 70 acres irrigated at a maximum combined rate of 0.83 cfs from all points of diversion.
