ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-13373

WATER DIVISION 2-B

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that a portion of surface water appropriation A-13373 located in the N $\frac{1}{2}$ SW $\frac{1}{4}$ of Section 10, Township 21 North, Range 5 East of the 6th P.M. in Cuming County is held by Dorothy M. Kreikemeier.
2. Records on file in the Department show that a portion of surface water appropriation A-13373 located in the S $\frac{1}{2}$ SW $\frac{1}{4}$ of Section 10, Township 21 North, Range 5 East of the 6th P.M. in Cuming County is held by Keith G. and Jodi L. Kreikemeier.
3. Appropriation A-13373 has a priority date of January 29, 1975, and authorizes the use of water for irrigation of the 135 acres of land described below. The water may be diverted from the North Branch of Pebble Creek at points of diversion located on both banks of the stream in the E $\frac{1}{2}$ SW $\frac{1}{4}$ of Section 10, Township 21 North, Range 5 East of the 6th P.M. in Cuming County. The rate that water may be diverted shall not exceed one cubic foot per second (cfs) for every 70 acres irrigated at a maximum combined rate of 1.93 cfs from all points of diversion.
