ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-15378

WATER DIVISION 1-A

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-15378 is held by the Cranford Family Revocable Trust.
2. Appropriation A-15378 has a priority date of December 26, 1978, and authorizes the use of water for irrigation of the 64.04 acres of land described below. The water may be diverted from Strever Creek at a point of diversion located on the left bank of the stream in the SW $\frac{1}{4}$ SW $\frac{1}{4}$  of Section 33, Township 10 North, Range 21 West of the 6<sup>th</sup> P.M. in Dawson County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum rate of 0.91 cfs.


