ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-18121

WATER DIVISION 2-B

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-18121 is held by Craig and Traci Moline.
2. Appropriation A-18121, with a priority date of December 12, 2002, authorizes the use of water for irrigation of the 179 acres of land described below. The water may be diverted from Wahoo Creek at a point of diversion located in the NW¹/₄NW¹/₄ of Section 3, Township 13 North, Range 8 East of the 6th P.M. in Saunders County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum rate of 2.56 cfs.


3. The approval of appropriation A-18121 was conditional upon the irrigation of the above land by September 1, 2005.
4. Department personnel performed a field investigation and determined the land approved for irrigation under appropriation A-18121 had not been irrigated by September 1, 2005.
5. *Nebraska Revised Statutes* § 46-229.02(7) provides for the cancellation of unused portions of surface water appropriations.

IT IS HEREBY ORDERED appropriation A-18121 is CANCELLED.
