ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION D-213A

WATER DIVISION 2-A

Background

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation D-213A is held by Joe E. and Debra J. Grantzinger.
2. Appropriation D-213A with a priority date of July 17, 1894, authorizes the use of water for irrigation of the 90.0 acres of land described below. The water may be diverted from Victoria Creek at a point of diversion located on the right bank of the stream in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 6, Township 19 North, Range 20 West of the 6th P.M. in Custer County. The rate that water may be diverted shall not exceed one cubic foot per second (cfs) for every 70 acres irrigated at a maximum rate of 1.29 cfs.
