ORDER GRANTING EXTENSION OF TIME BY PETITION EOT-2217

TO FILE MAP FOR TRANSFERS T-973 AND T-974

FOR WATER APPROPRIATIONS A-365R, P-270 AND A-768

GERING IRRIGATION DISTRICT

WATER DIVISION 1-A

Background

1. On June 22, 1994, the Department of Natural Resources (Department) approved Gering Irrigation District's (District) applications T-973 and T-974 to transfer the location of use for appropriations A-365R, P-270 and A-768. The approval was conditional upon a project map being filed by December 22, 2004.
2. On January 19, 2010, the Department approved the fourth extension of time in which to file the project map for the District's applications T-973 and T-974 for permits to transfer the location of use for appropriations A-365R, P-270 and A-768. The map filing date set by the extension Order was December 22, 2011.
3. On November 14, 2011, the District filed petition EOT-2217 and requests a fifth extension of time in which to file its project map for the above-mentioned transfers, due to the District's plans to update the boundary and file relinquishments. The District requests the deadline be extended to December 22, 2013.

Order

It is therefore ORDERED:

1. Petition EOT-2217 is hereby APPROVED.
2. The filing deadline for the required project map for transfers T-973 and T-974, and all subsequent relinquishments and assignments is extended to December 22, 2013.

3. All other conditions of appropriations A-365R, P-270 and A-768 remain in effect.
