ORDER GRANTING EXTENSION OF TIME BY PETITION EOT-2362

TO FILE MAP FOR TRANSFERS EXT-1983, EXT-1984, EXT-1985, and EXT-1986

FOR WATER APPROPRIATIONS A-9642, A-15088, A-17602 and A-18290

TWIN LOUPS RECLAMATION DISTRICT

WATER DIVISION 2-A

BACKGROUND

1. On June 29, 2011, the Department of Natural Resources (Department) approved expedited transfers, EXT-1983, EXT-1984, EXT-1985, and EXT-1986, filed by Twin Loups Reclamation District (District) to transfer the location of use of a portion of appropriations A-9642, A-15088, A-17602 and A-18290. The approval was conditional upon a project map prepared according to *Department Rules for Surface Water, Title 457 Neb. Admin. Code, Chapter 10* being filed by December 29, 2011.
2. On December 22, 2011, Ron Wolf, Manager, on behalf of the Twin Loups Reclamation District, filed petition EOT-2350 requesting an extension of time in which to file the project map for the above mentioned transfers, due to technical difficulties. The District requested the deadline be extended to June 29, 2012. An Order Granting Extension of Time by Petition EOT-2250 was approved on January 13, 2012.
3. On June 27, 2012, Ron Wolf, Secretary of the Board of the Twin Loups Reclamation District, filed Petition for an Extension of Time, EOT-2362, to file the project map for the above mentioned transfers, due to technical difficulties with the plotter at the Twin Loups Reclamation District. The District requests the deadline be extended to December 31, 2012.

ORDER

IT IS HEREBY ORDERED:

1. The extension request by petition EOT-2362 is hereby GRANTED.
2. The filing deadline to file project map showing EXT-1983, EXT-1984, EXT-1985, and EXT-1986 is extended to December 31, 2012.

3. All other conditions of appropriations A-9642, A-15088, A-17602 and A-18290 remain in effect.
