ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-4321

WATER DIVISION 1-A

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-4321 is held by the Harold Moles Testamentary Trust, and the Avis L. Moles Testamentary Trust.
2. Appropriation A-4321 has a priority date of August 7, 1948, and authorizes the use of water for irrigation of the 37 acres of land described below. The water may be diverted from Elm Creek at a point of diversion located on the south bank of the stream in the NW¹/₄NW¹/₄ of Section 3, Township 8 North, Range 18 West of the 6th P.M. in Buffalo County. The rate that water may be diverted shall not exceed one cubic foot per second (cfs) for every 115 acres irrigated at a maximum rate of 0.32 cfs.


