ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-3870R

WATER DIVISION 1-A

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-3870R is held by Mark F. and Cynthia D. Jacobson, the Estate of Ethel L. Jacobson and the Jacobson Family Trust.
2. Appropriation A-3870R has a priority date of February 3, 1920, and authorizes the use of water for irrigation for a total of 62.8 acres of land described below. The water may be diverted from Jacobson Reservoir (storage appropriation A-1576) at a point of diversion located on the east bank of the reservoir in Lot 6 of Section 31, Township 10 North, Range 16 West of the 6th P.M. in Buffalo County, for irrigation of the following described lands:


