APPROVAL OF MAP 18549 FOR WATER APPROPRIATION A-19085

WATER DIVISION 2-C

BACKGROUND

1. On May 24, 2013, Warren D. Wood filed in the Department of Natural Resources (Department) application A-19085 for a Permit to Appropriate Water.
2. On June 11, 2013, Warren D. Wood filed in the Department map number 18549 showing land proposed to be irrigated under application A-19085.

ORDER

IT IS HEREBY ORDERED:

1. Map number 18549 is APPROVED.
2. The following land is authorized to be irrigated (appurtenant land) under surface water appropriation A-19085 as depicted on map number 18549 which is made a part of this Order.

Township 30 North, Range 7 West of the
6th P.M. in Knox County Acres

Section 6: SE $\frac{1}{4}$ NE $\frac{1}{4}$ 2.0


3. Appropriation A-19085 has a priority date of May 24, 2013, and authorizes the appropriator the use of water for irrigation of the 2.0 acres of land described above. The water may be diverted from the North Branch of Verdigre Creek at points of diversion located on the left bank of the stream in the SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 6, Township 30 North, Range 7 West of the 6th P.M. in Knox County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum combined rate of .03 cfs from all points of diversion (13 gallons per minute).
4. Water diverted shall not exceed the ratio of one cfs for every 70 acres irrigated nor the least amount of water necessary for the production of crops in the exercise of good husbandry. Therefore, in any year when less than the maximum permitted acres are being irrigated, the quantity of water diverted at any time may be restricted to 1/70 cfs for each permitted acre being irrigated that year. This appropriation of water under any circumstance shall be limited annually to 3 acre-feet per acre of land on which water is actually and beneficially applied;

not to exceed the least amount of water necessary for the production of crops in the exercise of good husbandry.

5. The appropriator is bound by all terms and conditions of the approval of application A-19085.
