ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-15487

WATER DIVISION 2-A

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-15487 is held by Joseph M. Hickman.
2. The Department has received information that Laretta G. Hickman, wife of Joseph M. Hickman, may have a spousal interest in the land appurtenant to appropriation A-15487.
3. Appropriation A-15487 has a priority date of June 8, 1979, and authorizes the use of water for irrigation of the 173.1 acres of land described below. The water may be diverted from a tributary to Davis Creek at points of diversion located on the left bank of the stream in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 6, Township 16 North, Range 13 West of the 6th P.M. in Sherman County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum combined rate of 2.47 cfs from all points of diversion.


