APPROVAL OF EXPEDITED TRANSFER EXT-5150 FOR WATER APPROPRIATION A-16475

WATER DIVISION 1-C

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-16475 is held by Timothy Brewster.
2. Appropriation A-16475 has a priority date of March 10, 1986, and authorizes the use of water for irrigation of the 30 acres of land described below. The water may be diverted from the Little Blue River at a point of diversion located in the NE $\frac{1}{4}$ NE $\frac{1}{4}$  of Section 19, Township 4 North, Range 6 West of the 6<sup>th</sup> P.M. in Nuckolls County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum rate of 0.43 cfs.

Section 19: SE $\frac{1}{4}$ NE $\frac{1}{4}$  30

3. On September 10, 2014, Timothy Brewster filed application EXT-5150 for a permit for an expedited transfer of the location of use and map number 19061 showing the land proposed to be irrigated under appropriation A-16475 through transfer EXT-5150.

ORDER

IT IS HEREBY ORDERED:

1. Application EXT-5150 for a permit for an expedited transfer of the location of use and map number 19061 are APPROVED.



This appropriation is not a guarantee that water will be available. Nebraska law gives priority to senior appropriations. This appropriation may be closed if there is insufficient water to satisfy senior appropriations.
