APPROVAL OF MAP 19072 FOR WATER APPROPRIATION A-18509

WATER DIVISION 2-C

BACKGROUND

1. On May 2, 2007, Paul Young, on behalf of Gordon Valley Ranch Co., filed in the Department of Natural Resources (Department) application A-18509 for a Permit to Appropriate Water.
2. On October 27, 2014, Paul Young, on behalf of Gordon Valley Ranch Co., filed in the Department map number 19072 showing land proposed to be irrigated under application A-18509.

ORDER

IT IS HEREBY ORDERED:

1. Map number 19072 is APPROVED.
2. The following land is authorized to be irrigated (appurtenant land) under surface water appropriation A-18509 as depicted on map number 19072 which is made a part of this Order.

3. Appropriation A-18509 has a priority date of May 2, 2007, and authorizes the appropriator the use of water for irrigation of the 31.2 acres of land described above. The water may be diverted from Gordon Creek at a point of diversion located on the right bank of the stream in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 7, Township 31 North, Range 28 West of the 6th P.M. in Cherry County, as depicted on map number 19072. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 31.2 acres irrigated at a maximum rate of 0.45 cfs (202 gallons per minute).
4. Water diverted shall not exceed the ratio of one cfs for every 70 acres irrigated nor the least amount of water necessary for the production of crops in the exercise of good husbandry. Therefore, in any year when less than the maximum permitted acres are being irrigated, the quantity

of water diverted at any time may be restricted to 1/70 cfs for each permitted acre being irrigated that year. This appropriation of water under any circumstance shall be limited annually to 3 acre-feet per acre of land on which water is actually and beneficially applied; not to exceed the least amount of water necessary for the production of crops in the exercise of good husbandry.

5. The appropriator is bound by all terms and conditions of the approval of application A-18509.
