APPROVAL OF MAP 18397 FOR WATER APPROPRIATION A-19011

WATER DIVISION 2-C

BACKGROUND

1. On January 23, 2013, Barry Harthoorn filed in the Department of Natural Resources (Department) application A-19011 for a Permit to Appropriate Water and map number 18397 showing land proposed to be irrigated under application A-19011.
2. On January 30, 2013, Barry Harthoorn corrected filed map number 18397 showing land proposed to be irrigated under application A-19011.

ORDER

IT IS HEREBY ORDERED:

1. Map number 18397 is APPROVED.
2. The following is a description of all the land which is authorized to be irrigated (appurtenant land) under surface water appropriation A-19011 as depicted on map number 18397:

Appropriation A-19011 authorizes the appropriator the use of 191.87 acre-feet annually from Myron Nilson Reservoir (storage appropriation A-15640) from a pump site located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 29, Township 35 North, Range 19 West of the 6th P.M. in Keya Paha County, as depicted on map number 18397.
4. The appropriator is bound by all terms and conditions of the approval of application A-19011.
