APPROVAL OF MAP 18904 FOR WATER APPROPRIATION A-19232

WATER DIVISION 1-C

BACKGROUND

1. On April 14, 2014, Carl Elting filed in the Department of Natural Resources (Department) application A-19232 for a Permit to Appropriate Water.
2. On July 7, 2014, Carl Elting filed map number 18904 showing land proposed to be irrigated under application A-19232.

ORDER

IT IS HEREBY ORDERED:

1. Map number 18904 is APPROVED.
2. The following land is authorized to be irrigated (appurtenant land) under surface water appropriation A-19232 as depicted on map number 18904 which is made a part of this Order.



3. Appropriation A-19232 has a priority date of April 14, 2014, and authorizes the appropriator the use of water for irrigation of the 172.7 acres of land described above. The water may be diverted from the Little Blue River at a point of diversion located on the right bank of the stream in the SE $\frac{1}{4}$ NE $\frac{1}{4}$  of Section of Section 29, Township 4 North, Range 6 West of the 6<sup>th</sup> P.M. in Nuckolls, as depicted on map number 18904. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum rate of 2.47 cfs (1,108 gallons per minute).

4. Water diverted shall not exceed the ratio of one cfs for every 70 acres irrigated nor the least amount of water necessary for the production of crops in the exercise of good husbandry. Therefore, in any year when less than the maximum permitted acres are being irrigated, the quantity of water diverted at any time may be restricted to 1/70 cfs for each permitted acre being irrigated that year. This appropriation of water under any circumstance shall be limited annually to 3 acre-feet per acre of land on which water is actually and beneficially applied; not to exceed the least amount of water necessary for the production of crops in the exercise of good husbandry.
5. The appropriator is bound by all terms and conditions of the approval of application A-19232.
