APPROVAL OF MAP 19073 FOR WATER APPROPRIATION A-19300

WATER DIVISION 2-C

BACKGROUND

1. On September 17, 2014, Vernon and Pamela Hitchcock and the Margaret L. Hitchcock Life Estate filed in the Department of Natural Resources (Department) application A-19300 for a Permit to Appropriate Water.
2. On October 20, 2014, Vernon Hitchcock filed in the Department map number 19073 showing land proposed to be irrigated under application A-19300.
3. Construction has been completed.

ORDER

IT IS HEREBY ORDERED:

1. Map number 19073 is APPROVED.
2. The following is a description of all the land which is authorized to be irrigated (appurtenant land) under surface water appropriation A-19300 as depicted on map number 19073:

Appropriation A-19300 authorizes the appropriator the use of 51.3 acre-feet annually from Hitchcock Reservoir No. 3 (storage appropriation A-14416) from a pump site located in Section 33, Township 35 North, Range 17 West of the 6<sup>th</sup> P.M. in Keya Paha County, as depicted on map number 19073 to divert water for irrigation from this reservoir.

4. The appropriator is bound by all terms and conditions of the approval of application A-19300.
