ORDER OF CANCELLATION IN PART OF WATER APPROPRIATION A-13902

WATER DIVISION 1-F

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-13902 is held by the Stuart T. and LaVera Y. Schlichtemeier Trust.
2. Appropriation A-13902 has a priority date of December 9, 1975, and authorizes the use of water for irrigation of the 100.0 acres of land described below. The water may be diverted from Schlichtemeier Reservoir No. 2, storage permits A-13901 and A-14650, at a point of diversion located on left bank of the reservoir in the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 4, Township 10 North, Range 13 East of the 6th P.M. in Cass County. The rate that water may be diverted shall not exceed 4.44 acre-feet per annum.

3. On December 11, 2014, LaVera Y. Schlichtemeier, on behalf of the Stuart T. and Lavera Y. Schlichtemeier Trust filed in the Department relinquishment REL-5256, relinquishing the right to divert water under a portion of appropriation A-13902 to irrigate the 19.7 acres of land described below.

IT IS HEREBY ORDERED:

1. Part of appropriation A-13902 for use upon the land described below is CANCELLED.

2. Appropriation A-13902 now authorizes the appropriator to divert water from Schlichtemeier Reservoir No. 2, storage permits A-13901 and A-14650, to irrigate the 80.3 acres of land described below and depicted on map number 18935 which is made a part of this Order. The point of diversion remains in the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 4, Township 10 North, Range 13 East of the 6th P.M. in Cass County, as depicted on map number 18935. The amount of water that may be diverted shall not exceed 4.44 acre-feet per annum stored in Schlichtemeier Reservoir No. 2.

3. Appropriation A-13902 provides supplemental water to land authorized for irrigation under appropriation A-13080.
4. All terms and conditions of appropriation A-13902 remain in effect unless specifically changed by this Order.
5. The appropriator must comply with all relevant statutes. This includes, but is not limited to, the following:
 - A. Notify the Department of any change in ownership or address.
 - B. Notify the Department of the name and address of the person responsible for the use of the water appropriation (this may include farm managers, tenants, or relatives that actually apply the water to the approved use).

- C. Obtain approval from the Department prior to taking any action that changes the location of the point of diversion, the location of the place of use, the type of use, or the type of appropriation.

ADDITIONAL INFORMATION

Failure to comply with all laws and regulations pertaining to surface water appropriations and any orders issued by the Director of the Department of Natural Resources may result in the cancellation of the appropriation, temporary closing of the appropriation, administrative penalty, criminal prosecution, or any combination thereof.

Nebraska law provides that failure to use a portion or all of a perfected appropriation for more than five consecutive years may result in cancellation of the appropriation.
