ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-15247

WATER DIVISION 2-F

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-15247 is held by August Kalkowski.
2. A search of the records of the Knox County Register of Deeds indicates the land appurtenant to appropriation A-15247 includes the name of an owner that is different than the owners listed in Department records. This individual is Orpha Kalkowski.
3. Appropriation A-15247 has a priority date of April 27, 1978, and authorizes the use of water for irrigation of the 162 acres of land described below. The water may be diverted from Ponca Creek at points of diversion located on both banks of the stream in the NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 26, and on the left bank in the NE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 25 and the NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 26, Township 33 North, Range 08 West of the 6th P.M. in Knox County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum combined rate of 2.31 cfs from all points of diversion.
