APPROVAL OF MAP 19123 FOR WATER APPROPRIATION A-19311

WATER DIVISION 1-D

BACKGROUND

1. On November 20, 2014, Todd Evers on behalf of Brian Evers, Kent Evers and himself, filed in the Department of Natural Resources (Department) application A-19311 for a Permit to Appropriate Water.
2. On December 3, 2014, Todd Evers filed in the Department map number 19123 showing land proposed to be irrigated under application A-19311.

ORDER

IT IS HEREBY ORDERED:

1. Map number 19123 is APPROVED.
2. The following is a description of all the land which is authorized to be irrigated (appurtenant land) under surface water appropriation A-19311 as depicted on map number 19123:

Township 4 North, Range 7 East of the 6 <sup>th</sup> P.M. in Gage County	Acres

3. Appropriation A-19311 authorizes the appropriator the use of 13.28 acre-feet annually from Evers Farm Pond (storage appropriation A-18458) from pump sites located in the NW $\frac{1}{4}$ NE $\frac{1}{4}$  of Section 22, Township 4 North, Range 7 East of the 6<sup>th</sup> P.M. in Gage County, as depicted on map number 19123.

4. The appropriator is bound by all terms and conditions of the approval of application A-19311.
