APPROVAL OF MAP 18427 FOR WATER APPROPRIATION A-19015

WATER DIVISION 1-F

BACKGROUND

1. On January 24, 2013, Al Eickhoff, on behalf of L.A.H. Eickhoff Farms, Inc., filed in the Department of Natural Resources (Department) application A-19015 for a Permit to Appropriate Water.
2. On June 17, 2013, Al Eickhoff, on behalf of L.A.H. Eickhoff Farms, Inc., filed in the Department map number 18427 showing land proposed to be irrigated under application A-19015.

ORDER

IT IS HEREBY ORDERED:

1. Map number 18427 is APPROVED.
2. The following land is authorized to be irrigated (appurtenant land) under surface water appropriation A-19015 as depicted on map number 18427 which is made a part of this Order.



3. Appropriation A-19015 has a priority date of January 24, 2013, and authorizes the appropriator the use of water for irrigation of the 194.4 acres of land described above. The water may be diverted from Mackelroy Creek at points of diversion located on both banks of the stream in the SE $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 29, Township 3 North, Range 16 East of the 6<sup>th</sup> P.M. in Richardson County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum combined rate of 2.74 cfs from all points of diversion (1,230 gallons per minute).

4. Water diverted shall not exceed the ratio of one cfs for every 70 acres irrigated nor the least amount of water necessary for the production of crops in the exercise of good husbandry. Therefore, in any year when less than the maximum permitted acres are being irrigated, the quantity of water diverted at any time may be restricted to 1/70 cfs for each permitted acre being irrigated that year. This appropriation of water under any circumstance shall be limited annually to 3 acre-feet per acre of land on which water is actually and beneficially applied.
5. The appropriator is bound by all terms and conditions of the approval of application A-19015.
