APPROVAL OF MAP 18640 FOR WATER APPROPRIATION A-19062

WATER DIVISION 1-D

BACKGROUND

1. On July 26, 2013, the Department of Natural Resources (Department) approved application A-19062, filed by Earl Spitsnogle for a Permit to Appropriate Water from Spitsnogle Irrigation Reservoir (storage appropriation A-19061) for the purpose of irrigation. This approval was conditional upon the appropriator filing a map prepared according to *Title 457 Neb. Admin. Code Chapter 10* in the office of the Department by six months past the signing date of the application approval.
2. On September 12, 2013, Earl Spitsnogle filed map number 18640 showing the land proposed to be irrigated under A-19062.

ORDER

IT IS HEREBY ORDERED:

1. Map number 18640 is APPROVED.
2. The following is a description of all the land which is authorized to be irrigated (appurtenant land) under surface water appropriation A-19062 as depicted on map number 18640:

3. Appropriation A-19062 authorizes the appropriator the use of 38.1 acre-feet annually from Spitsnogle Irrigation Reservoir (storage appropriation A-19061) from a pump site located in the SW $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 19, Township 1 North, Range 6 East of the 6<sup>th</sup> P.M. in Gage County.

4. Appropriation A-19062 provides supplemental water to irrigate land under surface water appropriation A-18942 held by Earl Spitsnogle.
5. The appropriator is bound by all terms and conditions of the approval of application A-19062.
