APPROVAL OF MAP 18623 FOR WATER APPROPRIATION A-19121

WATER DIVISION 1-D

BACKGROUND

1. On August 8, 2013, the Department of Natural Resources (Department) approved application A-19121, filed by Wayne Lineweber for a Permit to Appropriate Water from Lineweber South Reservoir No. 2 (storage appropriation A-19120) for the purpose of irrigation. This approval was conditional upon the appropriator filing a map prepared according to *Title 457 Neb. Admin. Code Chapter 10* in the office of the Department by six months past the signing date of the application approval.
2. On August 21, 2013, James E. Brod, operator, on behalf of Wayne Lineweber, filed map number 18623 showing the land proposed to be irrigated under A-19121.

ORDER

IT IS HEREBY ORDERED:

1. Map number 18623 is APPROVED.
2. The following is a description of all the land which is authorized to be irrigated (appurtenant land) under surface water appropriation A-19121 as depicted on map number 18623:

Appropriation A-19121 authorizes the appropriator the use of 16.0 acre-feet annually from Lineweber South Reservoir No. 2 (storage appropriation A-19120) from a pump site located in the SE $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 20, Township 3 North, Range 6 East of the 6<sup>th</sup> P.M. in Gage County.
4. The appropriator is bound by all terms and conditions of the approval of application A-19121.
