APPROVAL OF APPLICATION A-19125, PETITION FOR A WAIVER OF DRAWDOWN DWV-4795

AND PLAN NUMBER 18638

WATER DIVISION 1-B

BACKGROUND

1. On July 14, 2004, the Department of Natural Resources (Department) issued an Order declaring a formal moratorium in the Republican River Basin on the issuance of all new surface water appropriations.
2. On January 25, 2013, Rick Troyer, Manager, on behalf of Louis Dinklage, LLC, filed petition VAR-3485 in the Department for Leave to File or Consider an Application for a New Surface Water Appropriation within a Moratorium Area. The draft application and documentation attached to the petition is for a permit to impound water in the existing Dinklage Clean Water Pond from a tributary to the Republican River located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$  of Section 7, Township 2 North, Range 10 West of the 6<sup>th</sup> P.M. in Webster County for the purpose of flood and erosion control.
3. On May 29, 2013, the Department granted petition VAR-3485 for leave to file an application for a permit to appropriate water.
4. On August 9, 2013, Rick Troyer, Manager, on behalf of Louis Dinklage, LLC, filed in the Department application A-19125 for a permit to impound water, application for approval of plans for dams, plan P-18638 and petition for a waiver of drawdown requirement, DWV-4795, pursuant to the proposed application filed with VAR-3485.
5. Construction has been completed.

ORDER

IT IS HEREBY ORDERED Application A-19125, plan number 18638, and DWV-4795 are APPROVED subject to the following limitations and conditions:

1. The source of water is a tributary to Dry Creek.
2. The priority date is August 9, 2013.
3. The amount of water that may be diverted shall not exceed 13.2 acre-feet per year to be stored in Dinklage Clean Water Pond. The dam that impounds water in Dinklage Clean Water Pond is located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$  of Section 7, Township 2 North, Range 10 West of the 6<sup>th</sup> P.M. in Webster County.

4. The water stored under this appropriation is for the purpose of flood and erosion control.
5. *Neb. Rev. Stat. § 46-241(5)* states in part, "The owner or possessor of a reservoir or intentional underground water storage facility does not have the right to store water in such reservoir or facility during the time that such water is required in ditches for direct irrigation or for any reservoir or facility holding a senior right. Every person who owns, controls, or operates a reservoir or intentional underground water storage facility, except political subdivisions of this state, shall be required to pass ... a portion of the measured inflows to furnish water for livestock ... ."
6. The owner or possessor of the reservoir storing water pursuant to A-19125 shall have structural controls in place or other mechanical means to immediately release a portion of the measured inflows in such amounts and at such times if so ordered by the Department.
7. A waiver of the requirement for a drawdown, DWV-4795, has been granted. This waiver does not relieve the owner from the responsibility to pass a portion of the reservoir inflow by some method for downstream appropriators should there be a need for water administration; or if water should be required for livestock needs, unless the appropriator is a political subdivision. The Department may rescind the waiver and require installation of appropriate outlet works at a later date if it is determined that the responsibility to pass inflows is not being met or cannot be met by another method.
8. The appropriator must comply with all relevant statutes. This includes, but is not limited to, the following:
  - A. Notify the Department of any change in ownership or address.
  - B. Receive approval prior to taking any action that changes the storage capacity of this reservoir, the specifications, plan P-18638, or the type of appropriation.
  - C. Construct, operate and maintain the structure in accordance with *Neb. Rev. Stat. § 46-241* and the *Safety of Dams and Reservoirs Act*, §§ 46-1601 to 46-1670.
  - D. Assume liability for all damages due to leakage, overflow or structural failure of the structure.
  - E. Release a portion of the reservoir inflows for livestock where required, unless appropriator is a political subdivision.

ADDITIONAL INFORMATION

Failure to comply with all laws and regulations pertaining to surface water appropriations and any orders issued by the Director of the Department of Natural Resources may result in the cancellation of the appropriation, temporary closing of the appropriation, administrative penalty, criminal prosecution, or any combination thereof.

Procedures Act* §§ 84-901 et. seq. RRS and the Department's *Rules of Practice and Procedure Title 454 Admin. Code Chapter 7*. The request must be received by the Department at its Lincoln office (Nebraska State Office Building, 4<sup>th</sup> Floor, 301 Centennial Mall South, P.O. Box 94676, Lincoln, Nebraska 68509-4676) within 30 days of the date of the Approval and be accompanied by a filing fee of \$10.
