APPROVAL OF MAP 18819 FOR WATER APPROPRIATION A-19189

WATER DIVISION 1-F

BACKGROUND

1. On February 3, 2014, Alan and Kelly J. Rippe filed in the Department of Natural Resources (Department) application A-19189 for a Permit to Appropriate Water.
2. On April 7, 2015, Alan Rippe filed in the Department map number 18819 showing land proposed to be irrigated under application A-19189.

ORDER

IT IS HEREBY ORDERED:

1. Map number 18819 is APPROVED.
2. The following land is authorized to be irrigated (appurtenant land) under surface water appropriation A-19189 as depicted on map number 18819 which is made a part of this Order.



3. Appropriation A-19189 has a priority date of February 3, 2014, and authorizes the appropriator the use of water for irrigation of the 124.2 acres of land described above. The water may be diverted from Long's Creek at points of diversion located on both banks of the stream in the NE $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 23, Township 5 North, Range 13 East of the 6<sup>th</sup> P.M. in Nemaha County, as depicted on map number 18819. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum combined rate of 1.77 cfs from all points of diversion (794 gallons per minute).

4. Water diverted shall not exceed the ratio of one cfs for every 70 acres irrigated nor the least amount of water necessary for the production of crops in the exercise of good husbandry. Therefore, in any year when less than the maximum permitted acres are being irrigated, the quantity of water diverted at any time may be restricted to 1/70 cfs for each permitted acre being irrigated that year. This appropriation of water under any circumstance shall be limited annually to 3 acre-feet per acre of land on which water is actually and beneficially applied; not to exceed the least amount of water necessary for the production of crops in the exercise of good husbandry.
5. The appropriator is bound by all terms and conditions of the approval of application A-19189.
