APPROVAL OF MAP 18941 FOR WATER APPROPRIATION A-19211

BACKGROUND

1. On March 21, 2014, Paul Soucie, on behalf of the Janet R. Soucie Life Estate, filed in the Department of Natural Resources (Department) application A-19211 for a Permit to Appropriate Water.
2. On July 10, 2014, Paul Soucie filed in the Department map number 18941 showing land proposed to be irrigated under application A-19211.

ORDER

IT IS HEREBY ORDERED:

1. Map number 18941 is APPROVED.
2. The following is a description of all the land which is authorized to be irrigated (appurtenant land) under surface water appropriation A-19211 as depicted on map number 18941:

Appropriation A-19211 authorizes the appropriator the use of 59 acre-feet annually from Skalka Reservoir (storage appropriation A-11952) from a pump site located in the SE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 8, Township 4 North, Range 7 West of the 6th P.M. in Nuckolls County, as depicted on map number 18941.
4. The appropriator is bound by all terms and conditions of the approval of application A-19211.
