BACKGROUND

1. On February 9, 2015, Charles L. Barber, on behalf of Marcy Barber and Angela and Chris Clifford, filed in the Department of Natural Resources (Department) application A-19332 for a Permit to Appropriate Water.
2. On May 22, 2015, Charles L. Barber, on behalf of Marcy Barber and Angela and Chris Clifford, filed in the Department map number 19249 showing land proposed to be irrigated under application A-19332.

ORDER

IT IS HEREBY ORDERED:

1. Map number 19249 is APPROVED.
2. The following land is authorized to be irrigated (appurtenant land) under surface water appropriation A-19332 as depicted on map number 19249 which is made a part of this Order.
