ORDER GRANTING EXTENSION OF TIME BY PETITIONS EOT-5700, EOT-5701, EOT-5702,  
EOT-5703 AND EOT-5704

TO FILE PROJECT MAPS FOR WATER APPROPRIATIONS A-19037, A-19038, A-19039,  
A-19040 AND A-19041

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show the following surface water appropriations were approved by the Department on December 22, 2015, and are held by Haveman Farms, Inc.: A-19037 (storage, Haveman Pond No. 1), A-19038 (supplemental storage), A-19039 (storage, Haveman Pond No. 2), A-19040 (irrigation from reservoir), and A-19041 (irrigation from reservoir).
2. Pursuant to the Order of Approval for the above mentioned surface water appropriations, project maps for the use of water and storage facilities were to be filed by June 22, 2016, six months after the approval date.
3. On June 21, 2016, Dale Haveman, on behalf of Haveman Farms, Inc., filed petitions EOT-5700, EOT-5701, EOT-5702, EOT-5703 and EOT-5704 in the office of the Department requesting a six-month extension of time in which to file surface water project maps. These petitions were filed in a timely manner prior to the June 22, 2016, deadline.

ORDER

IT IS HEREBY ORDERED:

1. Petitions EOT-5700, EOT-5701, EOT-5702, EOT-5703 and EOT-5704 requesting a six-month extension of time to file surface water project maps are hereby GRANTED.
2. The deadline to file surface water project maps under appropriations A-19037, A-19038, A-19039, A-19040, and A-19041 is extended to December 22, 2016.
