APPROVAL OF APPLICATION A-19423 AND MAP NUMBER 19475

WATER DIVISION 1-D

BACKGROUND

1. On March 4, 2016, Gary L. and Judy L. Carstens, Scott and Karla Carstens, and Jamie P. and Tammi L. Carstens filed in the Department of Natural Resources (Department) application A-19423 for a Permit to Appropriate Water and map number 19475 showing land proposed to be irrigated under application A-19423.
2. Construction has been completed.

ORDER

IT IS HEREBY ORDERED that application A-19423 and map number 19475 are APPROVED subject to the following limitations and conditions:

1. The following land is authorized to be irrigated (appurtenant land) under surface water appropriation A-19423 as depicted on map number 19475 which is made a part of this Order.

2. Appropriation A-19423 has a priority date of March 4, 2016, and authorizes the appropriator the use of 15.9 acre-feet annually from Carsten's Pond (storage appropriation A-19117) from a pump site located in the SE $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 28, Township 05 North, Range 07 East of the 6<sup>th</sup> P.M. in Gage County, as depicted on map number 19475.

3. This appropriation will be limited to the land irrigated and the amount of water beneficially used on an annual basis. Such amount shall not exceed 15.9 acre-feet per annum.
4. Only the land shown on map number 19475 may be irrigated under appropriation A-19423.
5. A measuring device, approved by the Department, may be required if so ordered by the Department.
6. The appropriator must comply with all relevant statutes. The statutes include, but are not limited to, the following:
  - A. Notify the Department of any change in ownership or address.
  - B. Notify the Department of the name and address of the person responsible for the use of the water appropriation (this may include farm managers, tenants, or relatives that actually apply the water to the approved use).
  - C. Obtain approval from the Department prior to taking any action that changes the location of the point of diversion, the location of the place of use, the type of use, or the type of appropriation.
7. The appropriator must comply with the following deadlines:
  - A. The appropriation is not considered perfected until water has been beneficially applied for the purpose stated in this approval. The water appropriated under A-19423 must be beneficially used by September 1, 2018.
  - B. After September 1, 2018, a field investigation will be conducted to determine the acres irrigated, after which an order of cancellation will be issued for any unused portions of appropriation A-19423.

ADDITIONAL INFORMATION

Failure to comply with all laws and regulations pertaining to surface water appropriations, any orders issued by the Director of the Department of Natural Resources, or the provisions of this Approval may result in the cancellation of the appropriation, temporary closing of the appropriation, administrative penalty, criminal prosecution, or any combination thereof.

Nebraska law provides that failure to use a portion or all of a perfected appropriation for more than five consecutive years may result in cancellation of the appropriation.
