ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-11917

WATER DIVISION 1-C

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-11917 is held by Charles William Roback.
2. A search of the records of the Clay County Register of Deeds indicates the land appurtenant to appropriation A-11917 is owned by the Ruth Roback Revocable Trust.
3. The Department has received information that Charles William Roback and Ruth S. Roback are deceased and that Paul W. Roback, Kristin Schultz, Kevin Roback, Randall K. and Jean R. Stinnette have an interest in the land associated with the Ruth Roback Revocable Trust.
4. Appropriation A-11917 has a priority date of April 9, 1970, and authorizes the use of water for irrigation of the 151 acres of land described below. The water may be diverted from a tributary to Big Sandy Creek at a point of diversion located on the left bank of the stream in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 08, Township 07 North, Range 08 West of the 6th P.M. in Clay County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum rate of 2.16 cfs.
