ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-19016

WATER DIVISION 2-F

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-19016 is held by Steve and Martha Nordby.
2. Appropriation A-19016, with a priority date of January 24, 2013, authorizes the use of water for irrigation of the 176.5 acres of land described below. The water may be diverted from Kerloo Creek at points of diversion located on both banks of the stream in the SE $\frac{1}{4}$ NE $\frac{1}{4}$  of Section 25, Township 30 North, Range 01 East of the 6<sup>th</sup> P.M. in Cedar County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum combined rate of 2.52 cfs from all points of diversion.


3. The approval of appropriation A-19016 was conditional upon the irrigation of the above land by September 1, 2015.
4. Department personnel performed a field investigation and determined the land approved for irrigation under appropriation A-19016 had not been irrigated by September 1, 2015.
5. *Nebraska Revised Statutes* § 46-229.02(7) provides for the cancellation of unused portions of surface water appropriations.

IT IS HEREBY ORDERED appropriation A-19016 is CANCELLED.
