**NOTICE OF PRELIMINARY DETERMINATION OF NONUSE
OF SURFACE WATER APPROPRIATION A-7593**

WATER DIVISION 2-F

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-7593 is held by Kay A. Weaver.
2. Appropriation A-7593 has a priority date of May 26, 1955, and authorizes the use of water for irrigation of the 37 acres of land described below. The water may be diverted from Ponca Creek at a point of diversion located on the left bank of the stream in the S $\frac{1}{2}$ NE $\frac{1}{4}$ of Section 20, Township 33 North, Range 08 West of the 6th P.M. in Knox County. The rate that water may be diverted shall not exceed 0.26 cubic foot per second (cfs).

3. The Department has received information concerning the use of surface water appropriation A-7593 and determined that the appropriation has not been used for its required purpose for more than five consecutive years.
4. At this time the Department knows of no reason for not using the appropriation that would be considered sufficient cause for nonuse under *Nebraska Revised Statutes* § 46-229.04.
5. In accordance with state law (*Nebraska Revised Statutes* § 46-229.02) this notice is to inform you that appropriation A-7593 will be cancelled unless the Department's determination is successfully contested.

6. The owner(s) of the land that may be irrigated under water appropriation A-7593 may:
 - A. Choose not to respond to this Notice. **If no timely response is received the Department will proceed to enter an order cancelling all of water appropriation A-7593.**
 - B. Contest the Department's Preliminary Determination by filing the enclosed contest form in the Department at its Lincoln office (Nebraska State Office Building, 301 Centennial Mall South, 4th Floor, P.O. Box 94676, Lincoln, Nebraska 68509-4676) by the close of business on July 25, 2016. No filing fee is required.
7. Enclosed are: (1) a copy of the laws governing cancellation of appropriations, *Nebraska Revised Statutes* §§ 46-229, 46-229.02, 46-229.03, 46-229.04 and 46-229.05; (2) a blank contest form; and (3) a copy of the report of Field Investigation which is the basis for the determination.
