ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-19093

WATER DIVISION 1-D

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-19093 is held by Carol J. Grummert and Donald C. Schuller.
2. Appropriation A-19093 has a priority date of June 11, 2013, and authorizes the use of water for irrigation of the 64.9 acres of land described below. The water may be diverted from the Big Blue River at a point of diversion located on the left bank of the stream in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 35, Township 02 North, Range 07 East of the 6th P.M. in Gage County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum rate of 0.93 cfs.
