ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-5501

WATER DIVISION 1-D

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that land located in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 13, Township 08 North, Range 08 West of the 6th P.M. in Clay County appurtenant to appropriation A-5501 is owned by Dorothy Hansen.
2. Records on file in the Department show that land located in the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 18, Township 08 North, Range 07 West of the 6th P.M. in Clay County appurtenant to A-5501 is owned by Bruce and Judy Schwenk.
3. Appropriation A-5501 has a priority date of August 26, 1953, and authorizes the use of water for irrigation of the 27 acres of land described below. The water may be diverted from the West Fork of the Big Blue River at a point of diversion located on the north bank of the stream in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 13, Township 08 North, Range 08 West of the 6th P.M. in Clay County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 140 acres irrigated at a maximum combined rate of 0.19 cfs.
