APPROVAL OF EXPEDITED TRANSFER EXT-1598 FOR WATER APPROPRIATION A-12812

WATER DIVISION 2-C

Background

1. Records on file in the Department of Natural Resources (Department) show surface water appropriation A-12812 is held by Lonnie A. Breiner.
2. Appropriation A-12812 has a priority date of February 21, 1973, and authorizes the use of water for irrigation of the 224.4 acres of land described below. The water may be diverted from Big Sandy Creek at points of diversion located in the NW $\frac{1}{4}$ NE $\frac{1}{4}$  and NE $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 3, Township 31 North, Range 15 West of the 6<sup>th</sup> P.M. in Holt County. The rate that water may be diverted shall not exceed one cubic foot per second (cfs) for every 70 acres irrigated at a maximum combined rate of 3.21 cfs (1441 gallons per minute) from all points of diversion.

3. Lonnie A. Breiner filed an application EXT-1598 for a permit for an expedited transfer of the location of use requesting a transfer of the land authorized to be irrigated by appropriation A-12812.
4. On December 3, 2008, Lonnie A. Breiner filed map number 17332 showing the land proposed to be irrigated under appropriation A-12812 through transfer EXT-1598.

Order

IT IS HEREBY ORDERED:

1. Application EXT-1598 for a permit for an expedited transfer of the location of use and map number 17332 are APPROVED.

2. Appropriation A-12812 through transfer EXT-1598 authorizes the use of water to irrigate 224.4 acres of land described below and depicted on map number 17332, which is made a part of this Order. The water may be diverted from Big Sandy Creek at points of diversion located in the NW $\frac{1}{4}$ NE $\frac{1}{4}$  and the NE $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 3, Township 31 North, Range 15 West of the 6<sup>th</sup> P.M. in Holt County. The rate that water may be diverted shall not exceed one cfs for every 70 acres irrigated at a maximum combined rate of 3.21 (1441 gallons per minute) cfs from all points of diversion. The total volume may not exceed 3 acre-feet per irrigated acre per year.

4. The appropriator must comply with all relevant statutes. This includes, but is not limited to, the following.
- a. Notify the Department of any change in ownership or address.
  - b. Notify the Department of the name and address of the person responsible for the use of the water appropriation (this may include farm managers, tenants, or relatives that actually apply the water to the approved use).
  - c. Obtain approval from the Department prior to taking any action that changes the location of the point of diversion, the location of the place of use, the type of use, or the type of appropriation.

Additional Information

Failure to comply with all laws and regulations pertaining to surface water appropriations, any orders issued by the Director of the Department of Natural Resources, or the provisions of this Approval may cause cancellation of part or all of this appropriation, temporary closing of the appropriation, administrative penalty, criminal prosecution, or any combination thereof.
