APPROVAL OF MAP 18041 FOR WATER APPROPRIATION A-18849

WATER DIVISION 2-C

BACKGROUND

1. On May 22, 2012, the Department of Natural Resources (Department) approved Daryll B. and Tamara L. Lightner's application A-18849 for a permit to appropriate water. This approval stated that a project map must be filed in the office of the Department by six months past the signing date of the application approval.
2. On August 1, 2012, Daryll B. Lightner filed in the Department map number 18041 depicting the land proposed to be irrigated under A-18849.

ORDER

IT IS HEREBY ORDERED:

1. Map number 18041 is APPROVED.
2. The following is a description of all the land which is authorized to be irrigated (appurtenant land) under surface water appropriation A-18849 as depicted on map number 18041:

3. Appropriation A-18849 authorizes the appropriator the use of 28.0 acre-feet of water annually from Vonasek Reservoir (storage appropriation A-5128). Water will be released from Vonasek Reservoir in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 11, Township 31 North, Range 3 West of the 6th P.M. in Knox County, and will flow downstream to Lightner Reservoir No. 2 (storage appropriation A-18339) where it will be withdrawn at a pump site located on the right bank of the reservoir in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 12, Township 31 North, Range 8 West of the 6th P.M. in Knox County.
4. Appropriation A-18849 provides supplemental water to irrigate land under surface water appropriations A-18847, A-18848, A-18850, and A-18851.
5. The appropriator is bound by all terms and conditions of the approval of application A-18849.
6. The appropriator must comply with all relevant statutes. The statutes include, but are not limited to, the following:
 - A. Notify the Department of any change in ownership or address.
 - B. Notify the Department of the name and address of the person responsible for the use of the water appropriation (this may include farm managers, tenants, or relatives that actually apply the water to the approved use).
 - C. Obtain approval from the Department prior to taking any action that changes the location of the point of diversion, the location of the place of use, the type of use, or the type of appropriation.


ADDITIONAL INFORMATION

Failure to comply with all laws and regulations pertaining to surface water appropriations, any orders issued by the Director of the Department of Natural Resources, or the provisions of this Approval may result in the cancellation of the appropriation, temporary closing of the appropriation, administrative penalty, criminal prosecution, or any combination thereof.

Nebraska law provides that failure to use a portion or all of a perfected appropriation for more than five consecutive years may result in cancellation of the appropriation.

Box 94676, Lincoln, Nebraska 68509-4676) within 30 days of the date of the order and be accompanied by a filing fee of \$10.
