APPROVAL OF MAP 18129 FOR WATER APPROPRIATION A-18892

WATER DIVISION 2-C

BACKGROUND

1. On March 19, 2012, Tim Reiser filed in the Department of Natural Resources (Department) application A-18892 for a Permit to Appropriate Water.
2. On April 2, 2012, Tim Reiser filed in the Department map number 18129 showing land proposed to be irrigated under application A-18892.

ORDER

IT IS HEREBY ORDERED:

1. Map number 18129 is APPROVED.
2. The following is a description of all the land which is authorized to be irrigated (appurtenant land) under surface water appropriation A-18892 as depicted on map number 18129:

Appropriation A-18892 authorizes the appropriator the use of 93.7 acre-feet annually from Reiser Reservoir (storage appropriation A-18483) from a pump site located in the SE $\frac{1}{4}$ SW $\frac{1}{4}$  and SW $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 5, Township 33 North, Range 13 West of the 6<sup>th</sup> P.M. in Boyd County.

4. The appropriator is bound by all terms and conditions of the approval of application A-18892.
