ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-10828

WATER DIVISION 1-C

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-10828 is held by William and Rebecca Mize, Jonathan and Linda Peters, James and Sharon Peters, and Dennis and Kathryn Degenhardt.
2. Appropriation A-10828 has a priority date of April 11, 1966, and authorizes the use of water for irrigation of the 35 acres of land described below. The water may be diverted from a tributary to Spring Creek at a point of diversion located on the left bank of the stream in the NW $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 3, Township 1 North, Range 4 West of the 6<sup>th</sup> P.M. in Thayer County. Water diverted shall not exceed the ratio of one cubic foot per second (cfs) for every 70 acres irrigated at a maximum rate of 0.50 cfs.


