ORDER OF CANCELLATION IN FULL OF WATER APPROPRIATION A-18701

WATER DIVISION 2-C

BACKGROUND

1. Records on file in the Department of Natural Resources (Department) show that surface water appropriation A-18701 is held by Leslie H. and Janice L. Graham.
2. Appropriation A-18701, with a priority date of April 12, 2010, authorizes the use of water for irrigation of the 859.4 acres of land described below. The water may be diverted from Louse Creek at points of diversion located in the NW¹/₄NW¹/₄ of Section 19 and the NW¹/₄NW¹/₄ of Section 30, both in Township 32 North, Range 9 West of the 6th P.M. in Holt County. The rate that water may be diverted shall not exceed one cubic foot per second (cfs) for every 70 acres irrigated at a maximum combined rate of 12.28 cfs from all points of diversion.
