BACKGROUND

1. On January 14, 2011, DeVern C. and June K. Hagemeyer filed in the Department of Natural Resources (Department) application A-18736 for a Permit to Appropriate Water.
2. On April 11, 2011, DeVern C. Hagemeyer filed map number 17766 showing the land proposed to be irrigated under A-18736.

ORDER

IT IS HEREBY ORDERED:


1. Map number 17766 is APPROVED.
2. The following is a description of all the land which is authorized to be irrigated (appurtenant land) under surface water appropriation A-18736 as depicted on map number 17766:

3. Appropriation A-18736 provides supplemental water to irrigate land under surface water appropriation A-18734 held by DeVern C. and June K. Hagemeyer.
4. The appropriator is allowed to divert 6.74 acre-feet annually from Hagemeyer Reservoir (storage appropriation A-18735) located in the SW¹/₄SW¹/₄ of Section 4, Township 5 North, Range 5 East of the 6th P.M. in Gage County.
5. The appropriator is bound by all terms and conditions of the approval of application A-18736.
