APPROVAL OF MAP 18542 FOR WATER APPROPRIATION A-19098

BACKGROUND

On June 20, 2013, Richard Wortmann, on behalf of Nancy Wortmann and himself, filed in the Department of Natural Resources (Department) application A-19098 for a Permit to Appropriate Water and map number 18542 showing land proposed to be irrigated under this application.

ORDER

IT IS HEREBY ORDERED:

1. Map number 18542 is APPROVED.
2. The following is a description of all the land which is authorized to be irrigated (appurtenant land) under surface water appropriation A-19098 as depicted on map number 18542:

3. Appropriation A-19098 authorizes the appropriator the use of 13 acre-feet annually from Wortmann Reservoir (storage appropriation A-18868) from a pump site located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$  of Section 11, Township 32 North, Range 2 West of the 6<sup>th</sup> P.M. in Knox County.
4. Appropriation A-19098 provides supplemental water to irrigate a portion of the land under surface water appropriation A-18660 held by Richard and Nancy Wortmann.

5. The appropriator is bound by all terms and conditions of the approval of application A-19098.
