ORDER GRANTING EXTENSION OF TIME TO COMPLETE CONSTRUCTION OF P-20235

BACKGROUND

1. The plan, P-20235, is for Baker Holding Lagoon 2 Dam, a proposed dam subject to the *Safety of Dams and Reservoirs Act*. The dam will be located in the NE 1/4 of Section 14, Township 15 North, Range 13 West of the 6th P. M. in Sherman County.
2. Baker Ag, LLC Inc., 79033 485 Road, Ashton, Nebraska 68817 is the owner of the proposed dam.
3. On June 7, 2018, Plan P-20235 was approved with the condition that construction be completed by November 1, 2019.
4. On August 21, 2019, Garrett Brossart of Settje Agri-Services and Engineering Inc. filed on behalf of Baker Ag, LLC Inc., a request to extend the construction deadline for P-20235 to November 1, 2021.
5. On September 14, 2021, Jacob Mayer of Settje Agri-Services and Engineering Inc. filed on behalf of Baker Ag, LLC Inc., a request to extend the construction deadline for P-20235 to November 1, 2022.

ORDER

It is therefore ORDERED:

1. The request for extension of time to complete construction of P-20235 is hereby APPROVED.
2. The date by which construction of P-20235 shall be completed is extended to November 1, 2022.
3. All limitations and other conditions in the June 7, 2018 Order approving Plan P-20235 remain in effect.
4. Upon completion of the construction, the owner shall file with the Department the enclosed "Construction Certification Form for Dams". Following receipt of this form, an approval to operate will be issued by the Department if it determines that the dam is safe to impound within the limitations outlined in this ORDER.
