ORDER GRANTING EXTENSION OF TIME TO COMPLETE CONSTRUCTION P-20235

BACKGROUND

- 1. On May 2, 2018, Pat Baker on behalf of Baker Ag LLC Inc., filed in the Department of Natural Resources (Department) an Application for Approval of Plans for Dams, plan P-20235, and associated specifications.
- 2. The plan, P-20235, is for the construction of Baker Holding Lagoon 2 Dam, a proposed waste control dam subject to the Safety of Dams and Reservoirs Act. The dam will be located in the NE $\frac{1}{2}$ of Section 14, Township 15 North, Range 13 West of the 6th P.M. in Sherman County.
- 3. The Baker Ag LLC Inc., 79033 485 Road, Ashton, Nebraska 68817, owns the proposed dam.
- 4. On June 7, 2018, plan P-20235 was approved with the condition that construction be completed before November 1, 2019.
- 5. On August 21, 2019, Garrett Brossart of Settje Agri-Services and Engineering, Inc. filed on behalf of Baker Ag LLC Inc., a request to extend the construction deadline for P-20235 to November 1, 2021.
- 6. On September 14, 2021, Jacob Mayer of Settje Agri-Services and Engineering, Inc. filed on Behalf of Baker Ag LLC Inc., a request to extend the construction deadline for P-20235 to November 1, 2022.
- 7. On October 6, 2022, Jacob Mayer of Settje Agri-Services and Engineering, Inc. filed on behalf of Baker Ag LLC Inc., a request to extend the construction deadline for P-20235 to November 1, 2023.

ORDER

It is therefore ORDERED:

- 1. The request for extension of time to complete construction of P-20235 is hereby APPROVED.
- 2. The date by which construction of P-20235 shall be completed is extended to November 1, 2023.
- 3. All limitations and other conditions in the June 7, 2018, Order approving Plan P-20235 remain in effect.
- 4. Upon completion of the construction, the owner shall file with the Department the enclosed "Construction Certification Form for Dams".
