ORDER GRANTING EXTENSION OF TIME TO COMPLETE CONSTRUCTION OF PLAN NUMBER P-20600

BACKGROUND

- 1. On November 2, 2020, Dean Weborg on behalf of Weborg Feedlot, Inc. filed in the Department of Natural Resources (Department) an Application for Approval of Plans for Dams, plan P-20600, and associated specifications.
- 2. The plan, P-20600, is for the construction of Weborg Feedlot Lagoon Dam, a proposed waste control dam subject to the *Safety of Dams and Reservoirs Act*. The dam will be located in the Northeast 1/4 of Section 28, Township 19 North, Range 49 West of the 6th P.M. in Morrill County.
- 3. Weborg Feedlot, Inc., 10330 US Highway 385, Bridgeport, Nebraska 69336, owns the proposed dam.
- 4. On December 14, 2020, plan P-20600 was approved with the condition that construction be completed before November 1, 2022.
- 5. On October 28, 2022, David Kucera of Settje Agri-Services and Engineering, Inc. filed on behalf of Weborg Feedlot, Inc. a request to extend the construction deadline for plan P-20600 to November 1, 2023.
- 6. On December 1, 2022, the Department extended the completion deadline to November 1, 2023.
- 7. On October 16, 2023, David Kucera of Settje Agri-Services and Engineering, Inc. filed on behalf of Weborg Feedlot, Inc. a request to extend the construction deadline for plan P-20600 to November 1, 2024.

ORDER

It is therefore ORDERED:

- 1. The request for extension of time to complete construction of plan P-20600 is hereby APPROVED.
- 2. The date by which construction of plan P-20600 shall be completed is extended to November 1, 2024.
- 3. All limitations and other conditions in the December 14, 2020, order approving plan P-20600 remain in effect.

4. Upon completion of the construction, the owner shall file with the Department the enclosed "Construction Certification Form for Dams".
