This matter comes before the Department of Natural Resources ("Department") upon the Joint Motion to Stay Case and Deadlines Pending Appeal filed by the Central Platte Natural Resources District, Lower Loup Natural Resources District, Loup River Public Power District, Cozad Ditch Company, and North Platte Natural Resources District (collectively, "Objectors") on January 11, 2023.

- 1. On December 12, 2022, the Department filed an Order dismissing Objectors from this matter for lack of standing.
- 2. Thereafter, Objectors timely filed their Notices of Appeal with the Department.
- 3. The Applicant, Platte to Republican Basin High Flow Diversion Project filed no response with the Department regarding Objectors' Joint Motion to Stay Case and Deadlines Pending Appeal.
- 4. The Department finds that a hearing to determine the Objectors' rights to a stay is unnecessary and hereby grants the Joint Motion to Stay Case and Deadlines Pending Appeal.
- 5. Within ninety (90) days of this Order, the Department will confer with the parties to schedule a status conference to either report on the resolution of the appeal or continue the stay for an additional ninety (90) days.

It is therefore ORDERED:

Objectors' Joint Motion to Stay Case and Deadlines Pending Appeal is GRANTED. The case is hereby stayed for ninety (90) days pending a status conference.
