**NOTICE OF PRELIMINARY DETERMINATION OF NONUSE
OF SURFACE WATER APPROPRIATION A-10366**

WATER DIVISION 2-B

1. Department records show that Surface Water Appropriation A-10366 is held by **Larry W. and John A. Tegeler**.
2. **Linda D. Tegeler and Jane C. Tegeler** may have a spousal interest in the land appurtenant to A-10366.
3. Appropriation A-10366 has a priority date of **May 6, 1964**, and authorizes use of water for irrigation on **105.7 acres**, described below. Water may be diverted from **Buffalo Creek** at a point of diversion located on the right bank of the stream in the **NW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 24, Township 24 North, Range 04 West of the 6th P.M. in Madison County**. The maximum diversion rate shall not exceed **1.51 cubic feet** per second (cfs).

4. Based on information received and records reviewed, the Department has determined that Appropriation A-10366 has not been used for irrigation for **more than five consecutive years**, as required by Nebraska law.
5. At this time, the Department is unaware of any sufficient cause for nonuse under **Neb. Rev. Stat. § 46-229.04**.
6. Pursuant to **Neb. Rev. Stat. § 46-229.02**, this Notice serves as preliminary notification that Appropriation A-10366 will be **cancelled** unless this determination is successfully contested.
7. Landowners with a legal interest in the land under this appropriation may:
 - A. Take no action. If no response is received by the deadline, the Department will proceed with cancellation of Appropriation A-10366.

- B. Contest this determination by submitting the enclosed **contest form** to the Department's Lincoln office (245 Fallbrook Blvd., Suite 100, Lincoln, NE 68521) no later than **December 12, 2025. No filing fee is required.**
