# NOTICE OF PRELIMINARY DETERMINATION OF NONUSE

# OF SURFACE WATER APPROPRIATION A-13782

### WATER DIVISION 2-F

- 1. Department records show that Surface Water Appropriation A-13782 is held by Marlin K. & Cynthia J. Kraemer.
- 2. Appropriation A-13782 has a priority date of **September 2, 1975**, and authorizes use of water for irrigation on **177.0** acres, described below. Water may be diverted from **South Creek** at a a point of diversion located on the right bank of the stream in the **NW**4NE4 of **Section 28, Township 29**North, Range 05 East of the 6<sup>th</sup> P.M. in Dixon County. The maximum diversion rate shall not exceed **2.53 cubic feet** per second (cfs).

- 3. Based on information received and records reviewed, the Department has determined that Appropriation A-13782 has not been used for irrigation for more than five consecutive years, as required by Nebraska law.
- 4. At this time, the Department is unaware of any sufficient cause for nonuse under Neb. Rev. Stat. § 46-229.04.
- 5. Pursuant to **Neb. Rev. Stat. § 46-229.02,** this Notice serves as preliminary notification that Appropriation A-13782 will be **cancelled** unless this determination is successfully contested.
- 6. Landowners with a legal interest in the land under this appropriation may:
  - A. Take no action. If no response is received by the deadline, the Department will proceed with cancellation of Appropriation A-13782.
  - B. Contest this determination by submitting the enclosed **contest form** to the Department's Lincoln office (245 Fallbrook Blvd., Suite 100,

Lincoln, NE 68521) no later than January 19, 2026. No filing fee is required.
